RxA CEO savs "points" well taken regarding incentives and inducements

After my commentary on "points and perks" in last week's issue of RxPress Now!, I'm glad to say I heard from a number of pharmacists who challenged what I said, and offered some constructive and very professional concerns about points and perks. I think those comments deserve recognition.

I heard the very cogent, compelling argument that while ACP shouldn't wantonly impose regulations on the business aspect of pharmacy, the reality of "points and perks" is eroding the pharmacy profession's ability to practice effectively, and is commoditizing the profession.

One member raised the important point that a growing number of patients are filling meds they don't need, or worse, are going without their meds to wait for "special points days". Other members raised the issue of commoditization, too, and suggested that points programs, in that way, damage respect for the profession.

The point was also made that pharmacists are being required to police an increased incidence of prescription abuse and compliance issues. And finally, some members who work in high-volume pharmacies expressed a concern about the high pressure, stress-filled, and potentially error-prone environment that special promotion days may foster.

I want you to know that RxA takes these issues very seriously, and that I'm glad we've heard from you. In every case, your privacy will be respected, and your opinion will count in the policy considerations of RxA. I must say that these arguments made by pharmacists are very convincing, and leave little doubt that many pharmacists are deeply concerned. I think this discussion is important to the profession. So, what do you think?
